The tenders received will be opened on the same day in the presence of the tenderers or authorised agents, in case tenders are not opened on the same day, subsequent date

NOTE:-

- 1 The Tenderer along with the tender should enclose the following copies of documents.
 - a Registration copy
 - b Up to date sales tax returns ending March 2008 with clearance certificate should be enclosed.
 - c Work done certificate for having done the work to the extent of tender applied for last 3 years.

- 2 The E.M.D. should be paid by the crossed demand draft/pay order only in favour of the commissioner. Corporation of the City of Belgaum from any scheduled bank.
- 3 The tender received after the due date and time and without valid EMD will not be considered.
- 4 Any details required may be obtained from the City Engineer(South) and City Engineer (North) office, during office hours.
- 5 The Quantities mentioned in the Schedule 'B' are tentative.
- 6 The contractor has to make his own arrangement to procure materials through authorised dealers and produce valid receipt.
- 7 The right of rejection of any or all tenders without assigning any reason is reserved with the Commissioner Corporation of the City of Belgaum.
- 8 If Holiday is declared during above mentioned dates, the next working day will be considered.
- 9 The Typographical errors if any with tender documents will not be a ground for any claim by the Contractors.
- 10 The rules as per P.W.G. 65 are applicable.
- 11 The Contractor has to make his own arrangement to procure Asphalt /Cement /Steel /PVC pipes through authorised Dealers and produce receipts.
- 12 The tested materials should be used & quality test reports should be furnished from either quality control Sub.Div.PWD/MI Belgaum or KLE/Gogate Engineering College Belgaum @ their own cost.
- 13 The contractor has to enclose the documents while putting the tender regarding machineries like, Paver, D.R.R, vibrator roller & Tipper by his own or on hire basis.
- 14 For the asphalt work the contractor has to maintain roads for a period of three years from the date of completion at his own cost. 10% of the amount put to tender will be retained from the bill and it will be returned after satisfactory maintenance of the road for three years subject to the condition of producing maintenance certificate every year from Corporation
- 15 Any other condition as deemed fit by this office will be imposed depending upon the merits of the individual case.
- 16 As per G.O.No.LD300 LET 2006 dated 28-02-2007, 1% of the estimated cost will be deducted from contractors bill towards payment to Karnataka State Building and other construction workers Welfare Board.
- 17 The Tender shall remain valid for a period of Six months from the last date of submission of the tender.
- 18 The decision of the Commissioner of C.C.B is final.
- 19 The detailed list of works indicated above can be had from the Corporation office notice board & City Engineer(South/North) respectively.
- 20 If the rate quoted by the contractor for any item (S) of work is below 25% of the rates provided in the estimate of the work. The contractor should pay the difference amount in form of DD/FDR alongwith the tender form otherwise the tender will be rejected.
- 21 Conditional tenders will be rejected
